

AGGREGATED PREA DATA January 1, 2020 through December 31, 2020

During each quarterly Performance and Quality Improvement (PQI) Committee meeting, the Committee reviews the Staffing Plan, discussing progress, status and any incidents or problems related to the staffing plan. In all of the reviews, the committee determined that the facility is in compliance and no issues needing correction were identified. On 12/31/2020, the PREA Coordinator and the PREA Compliance Manager completed the form documenting an annual Staffing Plan Assessment. The report found all areas to be in compliance. The staffing plan will continue to be reviewed during each quarterly PQI Committee meeting as well as annually.

The following summarizes all PREA-related incidents during this PQI reporting period (2020):

Hardware Secure:

July 21, 2020: Allegations. This incident was reported to CPS due to youth making allegations that a staff watched him use the bathroom. The incident was found "unsubstantiated". All necessary phone calls were made and all paperwork was completed.

Staff Secure:

April 25, 2020: A youth pulled down another youth's pants while on the unit. Youth began to fight and were separated. This incident was reported to CPS due to this being a sexual harassment. The incident was found "unsubstantiated". All necessary phone calls were made and all paperwork was completed.

April 26, 2020: A youth kissed another youth on the cheek. This started a fight between the youth and was separated by staff. This incident was reported to CPS due to this being a sexual harassment. The incident was found "substantiated". All necessary phone calls were made and all paperwork was completed.

June 14, 2020: A youth kissed another youth on the cheek several times and was also blowing kisses at youth. This incident was reported to CPS due to this being a sexual harassment. The incident was found "substantiated". All necessary phone calls were made and all paperwork was completed.

June 14, 2020: A youth forced another youth into the corner in the cafeteria and was whispering close to his ear. The youth then began blowing kisses at the other youth's face, cheek and ear. The incident was reported to CPS due to the incident being sexual harassment. The incident was found "substantiated". All necessary phone calls were made and all paperwork was completed.

June 23, 2020: A youth was found to be in another youth's room while the other youth was on the toilet. The other youth was escorted out of the other youth's room and back to his own room. The incident was reported to CPS due to the sexual harassment of the incident. The incident was screened out. All necessary phone calls were made and all paperwork was completed.

July 13, 2020: A youth repeatedly attempted to look in on another youth while he was going to the bathroom. The youth at the door watching also made several sexual comments. The incident was reported to CPS due to the sexual harassment nature of the incident. The incident was found "substantiated". All necessary phone calls were made and all paperwork was completed.


July 15, 2020: A youth made a comment to another youth that was sexual in nature. The youth asked to call CPS. The incident was reported to CPS because the youth asked to call due to the sexual harassment nature of the incident. The incident was screened out. All necessary phone calls were made and all paperwork was completed.

August 9, 2020: A youth approached another youth and started to dry hump him. That same youth also went up to another youth and made a sexual comment. The incident was reported to CPS due to the sexual harassment. The incident was found "unsubstantiated". All necessary phone calls were made and all paperwork was completed.

August 11, 2020: Allegations. 2 youth reported another youth was watching them shower while he was in his room. This incident was reported to CPS due youth wanting to report allegations. The incident was found "unsubstantiated". All necessary phone calls were made and all paperwork was completed.

August 15, 2020: Allegations. A youth reported to a supervisor that the staff on his unit during the night went into an empty room and used that bathroom. This incident was reported to CPS due to the youth wanting to file PREA. The incident was screened out. All necessary phone calls were made and all paperwork was completed.

August 18, 2020: Youth was seen opening the bathroom door while another youth was in the bathroom. The youth using the bathroom then 'mooned' the other youth and staff. The incident was reported to CPS due to the sexual harassment. The incident was found "substantiated". All necessary phone calls were made and all paperwork was completed.

September 21, 2020: A youth pulled down another youth's shorts and underwear in front of youth in the game room. The incident was reported to CPS due to the sexual harassment nature of the incident. The incident was found "substantiated". All necessary phone calls were made and all paperwork was completed.

September 27, 2020: A youth pulled down his pants and showed his butt after several youth would not leave from his door. The incident was reported to CPS due to the sexual harassment nature of the incident. The incident was found "substantiated". All necessary phone calls were made and all paperwork was completed.

October 10, 2020: A youth has his pants pulled down and his butt visible to several other youth. The incident was reported to CPS due to the sexual harassment nature of the incident. The incident was screened out. All necessary phone calls were made and all paperwork was completed.

October 24, 2020: 2 youth were horse playing and one youth made a sexual gesture toward the other youth. The incident was reported to CPS by the youth who has had past trauma. The incident was found "unsubstantiated". All necessary phone calls were made and all paperwork was completed.

December 5, 2020: Allegations. A youth claimed another youth walked past him while showering and looked in the shower. The incident was reported to CPS due to the sexual harassment nature of the incident. The incident was found "unsubstantiated". All necessary phone calls were made and all paperwork was completed.

December 26, 2020: A youth pulled down another youth's shorts and underwear 'exposing' that youth to nearby youth. The incident was reported to CPS due to the sexual harassment nature of the incident. The incident was found "substantiated". All necessary phone calls were made and all paperwork was completed.
